Issue 1: On the consent to conclude a surety agreement between PAO "Rosseti Moscow Region" and PAO "CREDIT BANK OF MOSCOW", which is an interested party transaction.

Decision:

- 1. Determine that the price of the surety agreement between PAO "Rosseti Moscow Region" and PAO "CREDIT BANK OF MOSCOW", which is an interested party transaction, cannot exceed 400,000,000 (Four hundred million) rubles.
- 2. Provide consent to a transaction a surety agreement between PAO "Rosseti Moscow Region" and PAO "CREDIT BANK OF MOSCOW" (hereinafter referred to as the Agreement), which is an interested party transaction, on the following essential conditions:

Parties of the Contract:

PAO "Rosseti Moscow Region" (Guarantor);

PAO "CREDIT BANK OF MOSCOW" (Bank).

Beneficiary:

AO "MOESK - Engineering" (Debtor)

Subject and price of the Agreement:

The Guarantor undertakes to be jointly and severally liable with the Debtor to the Bank for the performance of the Debtor's obligations under the Loan Agreement dated September 15, 2020 No. 0795/20, concluded between the Bank and the Debtor (hereinafter referred to as the Principal Obligation Agreement), in terms of repayment of loan debt (hereinafter referred to as the Credit) in the amount not exceeding 400,000,000 (four hundred million) rubles. 00 kopecks.

In accordance with the Agreement, the surety ensures the following requirements of the Bank:

- timely and complete fulfillment by the Debtor of all obligations under the Agreement of the main obligation in terms of the return of the amount of the Credit provided to the Debtor in the amount of the Debtor's debt at the time of satisfaction of the Bank's claims, but not more than 400,000,000 (Four hundred million) rubles. 00 kopecks;
- fulfillment by the Debtor of all unfulfilled obligations upon termination of the Agreement of the main obligation in terms of the return of the amount of the Credit provided by the Debtor.

The Guarantor agrees to be liable for the obligations for the new debtor in case of transfer to another person of the debt under the Principal Obligation Agreement, subject to the transfer of the debt under the Principal Obligation Agreement to any of the companies that are part of the Debtor's group of companies.

Under the Agreement, the Debtor's group of companies is represented by the following legal entities:

- Debtor;
- affiliated legal entities of the Debtor;
- affiliated legal entities of any of the persons included in the Debtor's group of companies.

Duration of the Contract:

The Agreement comes into force from the date of its signing by the Parties and is valid for 1 (one) year.

- 2) a person, spouse, parents, children, brothers and sisters of the half blood, adoptive parents and whose adopted persons are persons holding positions in the Management Bodies of the managing organization of the company, managing organization of the company, or a person who is the Manager of the Company.
- 3) a person controlling the company or managing organization (manager), to whom the functions of the sole executive body of the company were transferred, or having the right to give the company mandatory instructions.
